### Overview

This contract outlines an agreement and includes all contractual obligations made on  
  
between Vinnie & June Brow & Beauty Bar, hereinafter referred to as "Salon" and  
  
hereinafter referred to as "Client".

- Client agrees to hire the Salon to provide makeup services on the date and time agreed.
- Salon agrees to perform these services for the Client and any wedding party members included in this contract, under the Terms and Conditions of this contract.
- Client and Salon agree to the mutual promises set forth in this contract.

### Salon's Obligations to Client

- Salon will perform the services promptly on the date and time agreed.
- Salon will use their own products in the provision of the services.
- If on location, Salon will arrange a means of transportation to get to and from event location.
- If Salon employee is unable to perform services for any unforeseeable reason, or unavoidable situation, Salon agrees to arrange for an equally qualified Makeup Artist to complete the agreed upon services for the same agreed upon terms of payment.
- Salon will use appropriate sanitary practices, and only use professional cosmetic products that give high quality results, and that are safe (FDA approved) for the safety of Client and their wedding party attendants.
- Salon will be responsible for sub-contracting additional Makeup Artist, Assistants, or Hairstylists for large bridal parties in order to perform the services required in an appropriate timeframe. The need to hire any sub- contractors will be at the discretion of the Salon, and will not be guaranteed unless specified within this contract.

## Client's Obligations to Salon

- Client agrees to pay all rates and fees in a prompt and timely manner as specified in the Payment Agreement.
- If the Salon is traveling, Client is responsible for Salon's travel fees (i.e. parking fees, hotel rates and food allowance). Client will pay all travel fees to Salon, in full, two (2) weeks prior to event date.
- Client agrees to provide notice, in advance, all allergies or conditions. Client also agrees to have her bridal party and any other additional attendants receiving services from Salon or their Assistants to also give notice in advance, in writing, of any and all allergies or conditions.
- Regardless of any personal agreements made between the Client and any other members of their party, the Client agrees to assume all responsibility for fees not paid by members of their party to Client or their assistants.
- Client will provide the traveling artist with a safe and private work area at the location services are to be performed. This location will also provide the Artist with the capability of performing their services as described, by providing an appropriate area (table/flat surface) to work from, appropriate lighting, and electrical outlets if necessary.
- Client agrees to arrive to any agreed upon appointment times on time and failure to do so will result in extra charges.

Client agrees that Salon is only obligated to provide the services that are specified within this contract. Any

additional services added on the event date will only be accommodated if time allows and payment will be due in full before services are rendered. Salon cannot be held liable for any problems this presents abiding to the original timeline set in place.

**Client's Initials**

Payment for services agreed upon in this contract will be payable in full (minus any deposit paid) even if they are not performed due to time constraints.

**Client's Initials**

**Deposit**

Salon will hold the event date in their calendar only after a non-refundable deposit of \$100 is paid. This deposit will be applied toward the total balance.

The deposit can be paid at the trial.

Until this fee is paid, the Salon is within their right to commit to other appointments on your event date.

The deposit is non-refundable should you cancel your event.

The deposit cannot be transferred to another date or another individual, or another event.

The deposit does not hold a cash value or refund for gratuity.

The deposit can be paid in the form of Cash, Check, Money Order, or Credit Card.

**Client's Initials**

**Balance Due**

The remaining balance (total balance less deposit) is due, in full, two (2) weeks prior to the event date. The balance can be paid in the form of Cash, Check, Money Order, or Credit Card.

Regardless of any arrangements made between Client and the wedding party, it is the Client's responsibility to ensure payment is made to Salon and failure of any additional attendants to pay their balance will be the sole responsibility of the Client.

Any additional services performed by Salon on the event date will be payable in full on the Event Date in the form of Cash, or Credit Card

Any ancillary fees (i.e.: parking) the Salon incurs on the event date are payable, in full, on the event date unless previously factored into the total balance.

**Tardiness**

Client and wedding party will be scheduled for services at a specified time and are expected to arrive for their services at this agreed upon time.

A fifteen (15) minute grace period will be given, after which a "Wait Fee" will be incurred at a rate of \$25 per 15- for each Salon's Artist(s) and any subcontractors.

The Salon may have other events to service on your event date and, if you are late, may need to leave before all of the agreed upon services are rendered, due to time constraints.

Payment for services agreed upon in this contract are payable, even if they are not rendered due to tardiness of Client or members of the wedding party.

**Cancellation Policies**

In the event Client must cancel services:

- 1. The deposit is non-refundable
- 2. Contract pricing is expected to be paid in full and is non-refundable.

**Liabilities**

Allergies - Client must give Salon notice of any and all known allergies that Client (or members of their party) have to ingredients that could potentially be found in cosmetic products of anykind.

**Entire Agreement**

This contract represents all the terms and conditions agreed upon by the parties. No other understanding or representations, oral or otherwise, regarding the agreement shall bind any of the parties. This contract may not be amended, except in writing, and signed by both parties. In any action or proceeding involving a dispute between the Client and the Salon arising out of this contract, the prevailing party will be entitled to receive from the losing party reasonable attorney's fees
